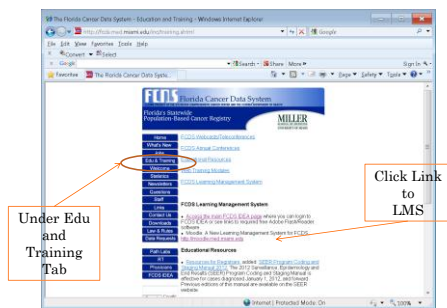

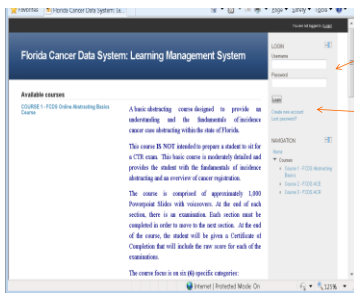

- Only individuals that are abstracting cancer data using the **full cancer abstract** in a hospital, Radiation Therapy or Ambulatory Surgical facility
- Physician office personnel using an abbreviated physician abstract **are not required** to have an abstractor code and therefore **not required** to renew their code

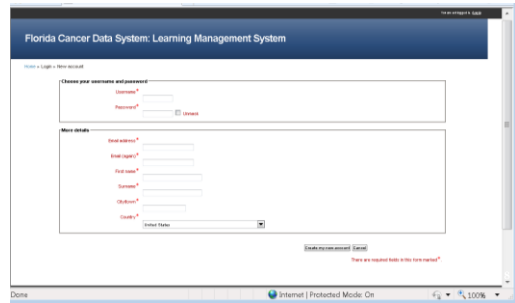

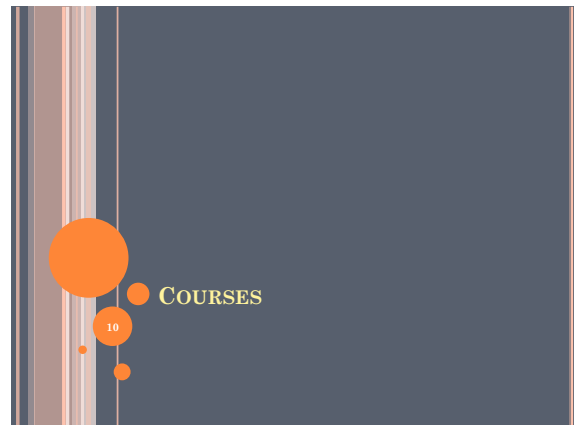

COURSE 1 – FCDS ONLINE ABSTRACTING BASICS COURSE

A basic abstracting course designed to provide an understanding and the fundamentals of incidence cancer case abstracting within the state of Florida. This course **IS NOT** intended to prepare a student to sit for a CTR exam. This basic course is moderately detailed and provides the student with the fundamentals of incidence abstracting and an overview of cancer registration. The course is comprised of approximately 1,000 Powerpoint Slides with voiceovers. At the end of each section, there is an examination. Each section must be completed in order to move to the next section. At the end of the course, the student will be given a Certificate of Completion that will include the raw score for each of the examinations.

- The course focus is on six (6) specific categories:
1. Basic abstracting knowledge
 2. General and Florida Only Rules
 3. Latest Rule Changes
 4. Primary Site, Histology, and Grade
 5. Stage at Diagnosis and Site Specific Factors
 6. Treatment

Duration: It is estimated that a student will spend approximately 40 hours completing this course. The exams at the end of the sections are comprised of between 5 and 20 questions each depending on the content of the section.

COURSE 2 – FCDS ABTRACTOR CODE EXAM

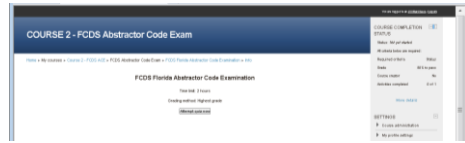
All **NEW** abstractors in the State of Florida, regardless of their CTR credentials, are required to take the FCDS Abstractor Code Examination to obtain a Florida Cancer Data System Cancer Abstractor Code. The exam focus is on competency in six (6) specific categories:

1. Basic abstracting knowledge
2. General and Florida Only Rules
3. Latest Rule Changes
4. Primary Site, Histology, and Grade
5. Stage at Diagnosis and Site Specific Factors
6. Treatment

Duration: This exam allows two hours for completion of 20 questions.

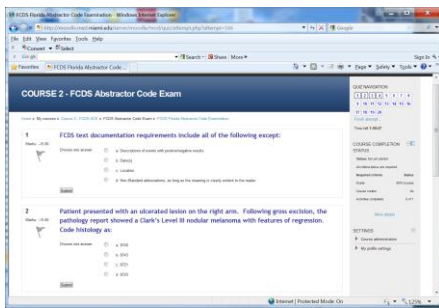

COURSE 3 – FCDS ABSTRACTOR CODE ANNUAL RENEWAL EXAM

All abstractors in the State of Florida are required to renew their abstractor code each year (based on the month of original issue).

The exam focus is on competency in six (6) specific categories:

1. Basic abstracting knowledge
2. General and Florida Only Rules
3. Latest Rule Changes
4. Primary Site, Histology, and Grade
5. Stage at Diagnosis and Site Specific Factors
6. Treatment

Duration: This exam allows one hour for completion of 15 questions.

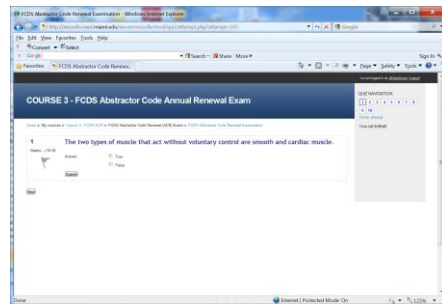

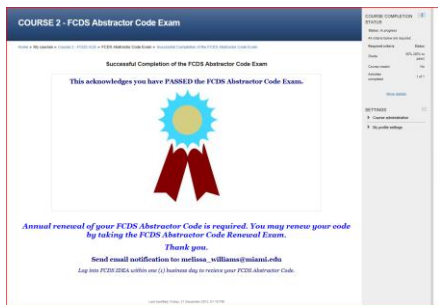

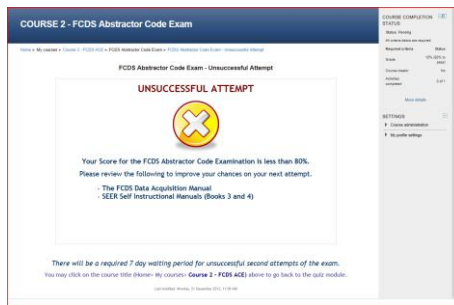
