






FCDS IDEA User Accounts

1.1 Do I need an FCDS IDEA User Account?
Yes, anyone accessing IDEA will need an FCDS IDEA User Account.

1.2 How do I create an FCDS IDEA user account?
Please follow the instructions as listed below:

- Access the FCDS homepage at <http://fcds.floridacancerdata.org>
- Click on the **FCDS LMS** link
- Click "Create an FCDS IDEA account"
- The "User Type Identification Screen" appears
- Select user role appropriate for your user account
- Click "Continue"
- The "Create FCDS User Account" screen appears
 - Create a password
 - Re-enter the password to verify
 - Re-enter your email address to verify
 - Select security questions and answer
 - Complete demographic information
 - Phone number/ Fax/ Alternate number
 - Complete mailing address
 - Verify your entries before clicking "submit"
 - Once you click **Submit** an e-mail is generated and sent to your email address. This email includes your assigned **Role** and Activation Information.
