Death Clearance Online Follow Back Process Webinar

September 3, 2008

Coding Lymphatic and Hematopoietic Malignancies

(for all diagnosis years) 2008 DAM, page 157

Leukemia/Lymphoma (Chronic Lymphocytic Leukemia [CLL] and Small Lymphocytic Lymphoma [SLL])

Code the diagnosis of chronic lymphocytic leukemia (9823/3) and/or small lymphocytic lymphoma (9670/3) to SLL if there are positive lymph nodes or deposits of lymphoma/leukemia in organs or in other tissue.

Code the histology to CLL if there are no physical manifestations of the disease other than a positive blood study or positive bone marrow.

Remember to use the 2008 DAM page 160, Section II Supplement A, "Definitions of Single and Subsequent Primaries of Lymphatic and Hematopoietic Diseases" to determine same versus subsequent primary for lymphatic and hematopoietic malignancies (See 2008 DAM link pages Hematologic Malignancies).
