#### Pathology Casefinding Is Still A Requirement for All Facilities

- This becomes especially important as we transition Disease Index Casefinding from ICD-9-CM to ICD-10-CM.
- It is all of our responsibility to ensure we completely identify all cancers and conduct pathology casefinding every year.
- Do not rely solely on Medical Record Coding and Facility Disease Index Casefinding.
- You will miss on average 5-15% of your annual cases if you do not conduct Path Casefinding at your facility.
- FCDS will begin conducting e-path follow-back on missed cases in the near future.

- New-To-Florida and Contract Registrars Not Using and Not Familiar with Florida Requirements

- New CTRs. non-CTRs and Contractors Abstracting Cases Without Local Supervision
- Registrars Taking Short Cuts with Documenting and Coding SSFs Analytic Cases
- Registrars are Assigning Seq 00 to all cases not reporting the historical cancers
- Registrars Taking Short Cuts with Text Documentation Required for Florida
- Registrars Submitting Far Too Many Unknown Primaries or C76.\*

- Rush to Deadline!!!


Please take time to complete high quality abstracts year round. When your facility uses interim contract abstracting services, it is your responsibility to ensure that the abstractors understand Florida Requirements and that the abstracting service provides FCDS with high quality data.

#### MPORTANT Meningioma Frequently Miscoded to Primary Site C70.9

FCDS continues to identify excessive incorrect assignment of primary site code C70.9 (meninges, NOS) for many of the reported meningioma cases. C70.9 should never be used when abstracting and reporting these "brain tumors". Meningioma is classified by a combination of Histologic Subtype, WHO Grade (behavior) and Tumor Location. More than 95% of meningiomas are benign. There are only 3 primary site codes available in ICD-O-3 to code meningioma; C70.0 (cranial meninges), C70.1 (spinal meninges) and C70.9 (meninges, NOS). The vast majority of meningiomas (90%) occur in the cranial meninges and are referred to as "brain tumors". Cranial meningiomas include meningioma of the sphenoid wing, cavernous sinus, foramen magnum, tentorium, posterior fossa and other intra-cranial sites and should be coded to primary site C70.0 not C70.9. Spinal meningioma (cord/column/space) is quite rare and should always be assigned primary site code C70.1 to distinguish it from cranial meningioma. FCDS will be introducing a new edit to eliminate this common error. Please take care when abstracting meningioma cases...you will always know whether they are cranial meningioma (C70.0) or spinal meningioma (C70.1).

In Remembrance of April Fritz November 19, 1949 – September 12, 2017



April Fritz passed away at her home in Reno, Nevada on September 12, 2017

April played a fundamental role in educating and training cancer registry professionals for more than four decades. She organized and conducted training events around the world, including Australia, Japan, Singapore, Nigeria, Saudi Arabia, Egypt, Canada, the United Kingdom and of course the United States. April served as a subject matter expert and consultant to numerous cancer research organizations, including the Commission on Cancer, the American Joint Committee on Cancer, SNOMED International, the International Agency for Research on Cancer, and the American Veterinary Medical Association.

Cancer was more than a matter of classification and statistics to April. She was a 25-year survivor of breast cancer and had been fighting pancreatic cancer for the last three and a half years.

April enjoyed travel, ballet, classical music, reading, cooking for and entertaining friends, and spending time with her rescued dogs. She also was on the Board of Directors of Golden Retriever Rescue, Education and Training (GRREAT) in Maryland for many years and edited their newsletter.

She is survived by her husband, Col. Robert G. Fritz and her sister, Robin Graham of East Moline, Illinois.

In lieu of flowers, it is requested that memorial donations be made to the NCRA Education Foundation. The family is working with NCRA to create a scholarship or educational program in April's name with the details being announced at the NCRA Annual Meeting in May.

#### Missed an FCDS Webcast or NAACCR Webinar?

Did you know that FCDS Webcasts and NAACCR Webinars can be viewed after-the -fact? FCDS Webcasts and NAACCR Webinars are recorded and posted on the FCDS Website (Education Tab). The FCDS Webcast recordings are available free of charge and can be viewed anytime/anywhere by anybody. However, starting in October 2017 the CEU award mechanism is restricted to approved FLccSC Users. Access to the NAACCR recordings is still password protected.

Recordings of FCDS Webcasts held 2014-2017 can be accessed from the FCDS Website. There are no CEU Quizzes for sessions held 10/2014-9/2017. However, your attendance must be manually logged into the FCDS CEU Tracking System for you to get credit for attending these recorded sessions.

Recordings of FCDS Webcasts held 10/2017 or later can be viewed either from the FCDS Website or in FLccSC, Florida's new Learning Management System. However, Registrars must have an active FLccSC Account and must take and pass the CEU Quiz to get any CEUs and to obtain a certificate of attendance.

NAACCR Webinars have their own CEU award mechanism whether viewed live or via a recorded session. Again, access to the NAACCR recordings is password protected. Only Florida registrars with Active/Current FCDS Abstractor Codes can access NAACCR Webinars per FCDS/NAACCR agreement.
